Scope

This bibliography lists publications related to child maltreatment issues authored by Sonja P. Brubacher. She is a research fellow with a background in Developmental Psychology at the Griffith Criminology Institute (GCI), Griffith University, Australia, and an interview trainer with the Centre for Investigative Interviewing. After receiving her PhD in Canada, she spent two years as a postdoctoral fellow at Central Michigan University and then as a research fellow & lecturer at Deakin University/Centre for Investigative Interviewing. Her research focuses on understanding the cognitive foundations underlying what children can remember about their experiences and the socio-motivational factors that influence whether and how those memories are reported, including memory for repeated events, interview protocol development, interviewer training, and interview preparatory phases (ground rules and narrative practice).
