Scope

This bibliography is a compilation of the work of Theodore P. (Ted) Cross. It includes articles, book chapters, books, newsletter articles, Infographics, book reviews, and technical reports. Dr. Theodore P. (Ted) Cross is a professor and senior research specialist in the School of Social Work at the University of Illinois at Urbana-Champaign (UIUC). For more than thirty-five years, he has studied a wide range of interventions on behalf of victimized and vulnerable populations, including multidisciplinary team responses to child maltreatment, forensic medical examinations for sexual assault victims, investigation and prosecution of child abuse, services for children and families in state child welfare systems, and development of coordinated, community-based children's mental health service systems. He has been an author of numerous peer-reviewed articles, book chapters, monographs, and technical reports as well as one professional book. He has been a principal investigator or project director on grants from numerous federal, state and private funders, including the Office for Victims of Crime, the National Institute of Justice, the Office of Juvenile Justice and Delinquency Prevention, the National Center on Child Abuse and Neglect, the Substance Abuse and Mental Health Services Administration, the Robert Wood Johnson Foundation, the Massachusetts Department of Social Services, and the Illinois Department of Children and Family Services. He was a Senior Research Psychologist for RTI International on the National Survey of Child and Adolescent Well-Being (NSCAW), the first national study that examines child and family wellbeing and relates it to their experience with the child welfare system and community environments. He directed the Multi-Site Evaluation of Children's Advocacy Centers, a five-year quasi-experimental study on effective methods of investigative and service response to allegations of child abuse. He has been the principal investigator or a senior researcher on a number of program evaluations of local, state and federal service programs, including the Mental Health Services Program for Youth of the Robert Wood Johnson Foundation, and the Children's Mental Health 2.0 and 3.0 Initiatives of the Illinois Children's Healthcare Foundation. He was a research specialist on the Child Victim as Witness Project funded by the Office of Juvenile Justice and Delinquency Protection, a pioneering study of the child mental health and criminal justice outcomes of prosecution of child abuse. For 15 years, he taught Advanced

Statistics in Psychology at Brandeis University. He is a licensed psychologist and has

maintained clinical practice in child and adult psychotherapy for many years.
