Scope

Dr. Kathleen Faller is the Marion Elizabeth Blue Endowed Professor Emerita of Children and Families in the School of Social Work at the University of Michigan, director of the Family Assessment Clinic and the principal investigator on the University of Michigan site of National Child Welfare Workforce Institute. She is involved in research, clinical work, teaching, training, and writing in the area of child welfare. She has written nine books and approximately 90 peer reviewed articles, conducted more than 300 juried international, national, and state conference presentations and presented more than 250 workshops addressing controversies of interviewing children about sexual abuse, the co-morbidity of child maltreatment and parental substance abuse, domestic violence, and substance abuse, cultural competence in child welfare, and child welfare workforce issues.
